### Gulf Consortium Finance and Budget Committee Meeting Minutes September 7, 2023 10:00am ET

### Go to Meeting

### Agenda Item #1 – Call to Order

Lawanda Pemberton called the meeting to order at 10:00 am.

#### Agenda Item #2 - Roll call

Valerie Seidel called the roll. Attendees above.

### Agenda Item #3 - Additions or Deletions

None from staff. Commissioner Robert Carroll made the motion to move the agenda as presented, seconded by Yana Matiyuk; passed by unanimous vote.

### Agenda Item #4 – Public Comments

No comments were made from the public.

### Agenda Item #5 – Consent Agenda

Meeting minutes for the June 14, 2023 Finance and Budget Committee Meeting and the Delegation of Authority Report through July 31, 2023 were presented. Yana Matiyuk made the motion to approve the consent agenda items, seconded by Commissioner Robert Carroll; passed by unanimous vote.

#### **ACTION: APPROVED**

### Agenda Item #6 - Financial Statements July 31, 2023

Richard Bernier provided the financial statements through July 31, 2023 and presented to the Committee for review and approval to the Board the Balance Sheet and Income Statement. There is \$40.08 million in the awarded grant balance with \$2.3 million of grant expenses.

There was also \$38.6k of adaptive planning expenses through July 2023 along with \$38k of general fund expenditures with a balance of \$86k. Receipts and expenditure reports from June 2023 through July 2023 were reviewed as well. There were no questions or comments.

Yana Matiyuk made the motion to approve the finance reports, seconded by Commissioner Robert Carroll; passed by unanimous vote.

#### **ACTION: APPROVED**

#### **Agenda Item #7- New Settlement Funds**

Valerie Seidel discussed additional funding that has become available. Gulf Consortium will receive additional amount of funds arising from Halliburton Energy Services Inc (HESI) and Transocean Ltd. Settlement. A copy of the order was provided. The amount of the distribution is not known. The original bp spill impact component ("Pot 3") funds were distributed among the 23 Gulf coast counties equally, resulting in a beginning balance of approximately \$12.7 million. The initial available funds were reduced by the costs of the Planning Grant of approximately \$2.9 million, the "Stand-up SEP" of \$215,000, and adaptive planning costs of about \$191,860, resulting in a balance of roughly \$12.6 million available to each County for projects.

Chair Lawanda Pemberton inquired if additional funds will be amended or could be applied to overrun. Valerie Seidel responded that there are still details to work out, but the expectation is that funds could be added to existing approved SEP projects or approved SEP projects that have yet to be active. The funds will need to be tracked separately as co-funding from a third source. Commissioner Robert Carroll made the motion to approve, seconded by Yana Matiyuk; passed by unanimous vote.

**ACTION: APPROVED** 

#### Agenda Item #8- Proposed Budged

Valerie Seidel presented the proposed budget for the next fiscal year, October 1 to September 30. For the fiscal year 2022-2023, costs are estimated to total approximately \$57,000 and include approximately 270 hours of management time. For the fiscal year 2023-2024, costs are estimated to total approximately \$88,865 and include approximately 350 hours of management time. Approximately \$10,000 of costs are incurred that are anticipated to be covered by a pending amendment to the adaptive planning grant. Current year legal costs have been well under budget but contractual caps allow for \$100,000. Meeting and travel expense are budgeted for one inperson meeting. The Adaptive Planning Grant funds are budgeted at \$82,516. SEP Funds are based on the grant application submissions received from the counties. Staff budgeted for about \$101 million during the current year, using the SEP-planned grant milestones to date. For FY 2023-24, staff is budgeting for additional projects targeted for the fiscal year of about \$89 million, and estimating 1/2 for draw-downs in the current year. This is well below the trust fund balance of \$159.7 million. The budget assumes one in-person meeting as per Board direction. Valerie explained that budgeted adaptive planning and county funds are being kept essentially flat, as there is uncertainty with the new funds whether additional set-up efforts will be required; otherwise the budget would have been reduced. Chair Lawanda Pemberton inquired how unspent budget funds are accounted for. Valerie Seidel responded that they are rolled over to the following year. Commissioner Robert Carroll made the motion to approve, seconded by Yana Matiyuk; passed by unanimous vote.

Richard Bernier presented Budget Summary and Project Status Expenditures through July 31, 2023 showing budget and expenditures by grant. Chair Lawanda Pemberton inquired about the meaning of a project status stated as withdrawn. Richard Bernier responded that it means those funds have been withdrawn from the grant. Chair Lawanda Pemberton inquired if unused funds remain with the county. Valerie Seidel responded that unused funds go back into the pool but are available for that count at any time. Yana Matiyuk made the motion to approve the budget summary and project status expenditure, second by Commissioner Robert Carroll; passed by unanimous vote.




