Agenda Item # 2 Transition Budget Options

Executive Summary: At the Gulf Consortium meeting held January 18, 2013, agenda item 7d was tabled by majority vote. During the discussion, the Directors' requested the Executive Committee to bring back options.

Background: The transition budget was intended to provide the Interim Manager (Florida Association of Counties) the resources to support the start-up and initial operation of the Gulf Consortium.

<u>Analysis:</u> Conceptually, the transition budget was intended to provide the Interim Manager necessary resources until RESTORE Act allocations were received. Conceptually, the interim budget required by the ILA was envisioned to be formulated upon receipt of fines.

With no definitive timeframe for receipt of fines, the Consortium needs to determine if an extension of the current transition budget is desired and whether to continue the methodology for allocation of contributions. Here is a recap of that methodology:

- Estimated expenses were allocated 75% to the 8 Disproportionally Affected Counties and 25% to the 15 Non-disproportionally Affected Counties.
- Within each of those allocations, anticipated percentages of allocations from Pot #1 State Allocation/Local was calculated to determine the share.
- Based on current spend rate (approx \$10k @ month), the transition budget will require additional resources in March 2013.

The below spreadsheet was developed to provide the Executive Committee options for consideration.

Option #2 = 4 fiscally constrained counties from 15 non-disproportionally affected counties @ pay \$1000. 3 fiscally constrained counties from disproportionally affected counties @ pay \$3044. Remaining 16 counties pay equal share.

Option #3=4 fiscally constrained counties from 15 non-disproportionally affected counties @pay \$1000. Remaining 19 counties pay equal share.

Agenda Item # 1 Re Appointment of Two Officers to the Executive Committee

Executive Summary: The Chairman, Vice-chairman and Secretary-Treasurer are required to appoint two directors to fill out the five member Executive Committee. Eight directors have properly indicated their interest in serving on the Executive Committee. The selection process requires the approval by a majority of the three person elected members of the Executive Committee. When chosen, the appointees will serve a one year term.

The nominees for appointment to the Executive Committee are listed in alphabetical order based on surname:

Background: The Interlocal Agreement establishes three elective officers: Chairman, Vice-Chairman and Secretary-Treasurer. The three elective officers were elected at the January 18, 2013 of the consortium. The three elected officers are required to appoint two other Directors to the Executive Committee so that the Committee consists of five Directors. Each of the appointed officers serves a one year term on the Executive Committee. Certain duties and powers are delegated to the Executive Committee as provided in Section 3.11 of the Interlocal Agreement establishing the Gulf Consortium.

<u>Analysis:</u> The Interlocal Agreements requires the three elected members to appoint two members from among the Directors who qualified to the Executive Committee.

<u>Option:</u> From the eight nominees, appoint two to serve on the Executive Committee. A motion from one of the three elected members to appoint a Director initiates the selection process. A majority vote of the Chairman, Vice-chairman and Secretary-Treasurer shall be required for the selection of each of the officers to serve on the Executive Committee. Voting shall continue until a

majority vote of the Elected Officers present is achieved for a candidate for the office.

I hereby request your consideration to perform on the Executive Committee of the Gulf Consortium in any of the five positions. I have been actively involved with both the Natural Resource Damage Assessment (NRDA) program since November 2010 and with the enactment of the RESTORE Act federal legislation since "Day 1"as Okaloosa County's designated representative. In both of these programs, I have interfaced with commissioners and other representatives of the "8 Disproportionally Affected Counties" in coordinating with various State agencies for NRDA and, for RESTORE, with FAC staff and our Florida Congressional Delegation in crafting the legislation. I have participated in every meeting of these groups. I am also Okaloosa County's representative on the Governor's Oil Spill Commission (post-Deepwater Horizon) to document lessons learned and make recommendations going forward, and was elected Vice-Chairman by the Commission members.

<u>Education</u>: MBA in Management; B.S. in Psychology; A.A. in Real Estate; CCC Graduate with FAC; enrolled in ACC course with FAC; various leadership schools with the U.S. Air Force (Squadron Officer School; Air Command and Staff College; Squadron Commander Course), among others.

<u>FAC Involvement</u>: During Florida's 2011 Legislative session, I made multiple trips to Tallahassee to testify before multiple Senate and House committees and sub-committees in support of the FAC legislative priorities. Of particular note are the Pretrial Services, Internet Lodging Reservations, and the Septic Tank legislation. In June 2011, I received FAC's Marlene Young Award, primarily for my actions and testimony in helping the defeat of the Pretrial Services legislation. In June 2012, I received the FAC President's Award. A successful military career requires <u>teamwork</u> to get the mission accomplished. I have owned and operated two successful businesses, one as a licensed sub-contractor in housing construction and the other in retail sales.

Members of the Executive Committee of the Gulf Consortium:

On behalf of the Board of County Commissioners of Monroe County, and as Monroe County's Director the Gulf Consortium, I would like to take this opportunity to express our respect and support for the 8 disproportionately-impacted counties, so deeply impacted by the Deepwater Horizon Oil Spill event, and our commitment to the successful, seamless continuation of efforts by the representatives those 8 counties who have done the heavy lifting on behalf of all 23 counties of the Gulf Consortium.

With RESTORE Act funding, we have an unparalleled opportunity to positively impact the communities and residents of the entire Gulf region for decades to come, and I will do all I can to aid in the Consortium's success. I believe that my extensive environmental knowledge and experience as well as a proven track record in collaboration, partnership and consensus-building would be of value to the Consortium's Executive Committee.

I humbly request your consideration for selection as one of the appointed representatives to the Executive Committee and offer a brief overview of my credentials below:

- Currently serving my fourth term as County Commissioner, and third time as Mayor, representing the Commission. (During this tenure, the County has neared the completion of a complex, multi-jurisdictional \$900M federally and state-mandated advanced wastewater treatment infrastructure project spanning the entire island chain of the Florida Keys.)
- Served on the Florida Keys National Marine Sanctuary Advisory Council for 14 years, with 7 of those years as Chair. (The FKNMS encompasses 2,900 sq. nautical miles of waters surrounding the Florida Keys and was established in recognition of and to protect the unique and complex marine ecosystem. The NMS is administered by NOAA and jointly managed with the State of Florida.)
- Served on the Steering Committee of the Water Quality Protection Program for 14 years, a program administered by US EPA and FDEP. (The program is designed to monitor, improve and maintain water quality in order to protect the coral reefs, seagrass meadows, and marine and benthic habitats of the National Marine Sanctuary.)
- Served on the South Florida Regional Planning Commission for 13 years, with 6 years of those years on the Executive Committee. (The SFRPC is a broad, collaborative effort to improve the economy, environment and vibrancy of the communities in South Florida.)
- Completed FAC's **Advanced and Certified County Commissioner** Education Programs. Monroe County is an active and long-standing member of the Florida Association of Counties and the Small County Coalition.

I hope that you will also consider the national significance and Gulf-wide environmental and economic impacts of Monroe County's marine ecosystem, as well as its vulnerability, in your selection of appointments to the Executive Committee:

- As a chain of 800 islands, spanning 220 miles from the tip of the Florida peninsula into the Gulf of Mexico, and 90 miles from the island of Cuba, Monroe County has the highest level of exposure to both domestic & international energy extraction activities (oil drilling, natural gas, etc.) on both the Gulf of Mexico and Atlantic Ocean coastlines. Except for the grace of God and the idiosyncratic nature of the Loop Current, Monroe may well have been the ninth disproportionately-impacted county.
- With a coastline that extends from the Everglades to the Dry Tortugas, Monroe County has the
 longest coastline of exposure on the Gulf of Mexico. This precious coastline overlaps the
 Florida Keys National Marine Sanctuary, 3 National Parks (Everglades, Dry Tortugas and
 Biscayne), 6 State Parks, 4 National Wildlife Refuges, and 3 state aquatic preserves.
 Monroe County has also designated by the State of Florida as an Area of Critical State Concern.
- Monroe County is the **only county on the Gulf coast with a barrier reef**. The coral reef tract in the Florida Keys is the third largest in the world, and the only living reef in the continental US. This reef environment generates more than **70,000 jobs and \$6 billion dollars** in **economic activity annually**, according to a study published in 2005 by the University of Miami.
- Seagrasses are among the richest, most productive, and most important coastal habitats, and Monroe County's marine ecosystem is home one of the largest seagrass beds in this hemisphere.
- Monroe County's marine ecosystem supports over 6,000 species of fish, invertebrates and plants providing unparalleled support to fisheries and essential habitats throughout Florida, the Gulf of Mexico and southeast Atlantic coasts. Monroe County provides critical spawning habitats to over 520 species of recreational and commercial migratory, endemic, coastal & pelagic finfish and shellfish, according to NOAA's Florida Keys National Marine Sanctuary Revised Management Plan, 2007.
- Monroe County's near shore waters alone provide habitat for 80 percent of the fish species in the U.S. and most commercially valuable fish species depend on Monroe County nearshore waters at some point during their development, according to the US Army Corps' Florida Keys Water Quality Improvement Program Management Plan, 2006.
- Monroe County is the **only port in the entire state of Florida to rank among the nation's top 50 ports** in landings tonnage or landings value. In fact, with \$56M in landings value, it is the **13th most valuable port the nation and the 5th most valuable port in the Gulf of Mexico**, according to NOAA's Fisheries of the United States, 2011, dated August 2012.
- With the highest number of recognized International Game Fish Association (IGFA) all tackle, saltwater line class, and saltwater flyrod "World Record Game Fish" records, Monroe County is the global center of recreational and sport fishing.
- The Florida Keys marine environment supports Monroe County's number one industry: tourism. Each year, \$1.2 billion is spent by over 3 million visitors. (FKNMS Revised Management Plan, 2007)
